### WILD CARD – SERVICE KIT

Entering the 2017 Italian Speed Racing Championship (CIV) requires the payment of an all-inclusive entry fee for each class, as a wild card in the **START LIST**, comprising the following:

- 1) Admission to the Start List for the individual competition being entered.
- 2) One free timed practice session on Fridays prior to competition. In order to take part in free practice sessions all riders must sign a disclaimer. With regard to minors, the disclaimer must also bear the self-certified signature of the person having paternal authority (pursuant to law). Riders are required to undergo technical and sports checks prior to free practice.
- 3) a) 4 (four) one-event person passes. The passes shall be handed over to the rider or team manager inside the appropriate envelope.
  - 1 (one) pass for the rider (mandatory)
  - 3 (three) passes for Technical Staff
  - 1 (one) Guest passes

pit lane + grid access; pit lane + grid access; paddock access;

b) 1 car pass for authorised parking and 1 pass for campers not transferable to third parties.

- c) 1 (one) scooter pass for moving within the paddocks. No other means will be allowed.
- 4) Paddock space for support vehicle and workshop tent.

The paddock management service shall provide each rider with an area where a <u>support vehicle</u> <u>and/or workshop tent</u> (usually calculated based on the vehicle size) may be parked/placed. For riders entered with accredited teams, the area shall be deemed to be the one allocated to the teams themselves.

No other facilities or hospitality areas may be installed. No commercial or promotional activity may be conducted without the consent of the Italian Motorcycling Federation.

Cars may be parked only in the areas designated by the Paddock Management Service. Campers and caravans, **if authorized**, may be parked **ONLY** in the designated areas; <u>only one camper or caravan per rider shall be allowed</u>, on condition that such vehicle is used as accommodation by the rider and not by any accompanying person.

- 5) Publishing the list of participants, complete with photo, on the website (www.civ.tv).
- 6) Eligibility for prize money awards for the selected class.
- 7) Eligibility for merit award through special rankings.

The envelope containing all the competition-related documents (including passes) must be collected by the rider
