WILD CARD RIDER - SERVICES KIT

Italian Road Racing Junior Championship WILD CARD entry (CIV Junior 2023) includes:

- 1) Participation in the title of Italian Road Racing Junior Championship 2023.
- 2) Admission to Start List only for the single race requested
- 3) Timekeeping and information distribution service.
- 4) a) Five (Nr. 5) pass (permanent or one event at the discretion of the rider). Passes will be given to the rider inside his envelope.

1 (one) compulsory for the rider pit lane + grid
 2 (two) passes for Technician Staff pit lane + grid;
 2 (two) passes for Guests paddock

b) One (Nr.1) car pass for authorized parking and One (Nr.1) technical pass both valid for the whole season and not transferable to third parties.

5) Paddock space for technical vehicle and workshop tent. it will not be allowed to carry out commercial or promotional activities without authorization from the Italian Motorcycling Federation.

Cars can only be parked in the areas indicated by the Paddock Management Service.

It is possible to do WILD CARD entries no more than 3 round (6 races in case of double races)

The rider's envelope containing all the documents about to the race (including passes) must be collected by the rider, a parent or Team Manager (in case of participation with a CIV Junior 2023 accredited Team) and also exclusively if all documentation of the rider is in order).
