- 4) Timekeeping and information distribution service.
- 5) a) Five (Nr. 5) pass (permanent or one event at the discretion of the rider). Passes that won't chose as permanent will be given to the rider race by race inside his envelope.
  - Nr. 1 (one) compulsory for the rider pit lane + grid
  - Nr. 2 (two) passes for Technician Staff pit lane + grid;
  - Nr. 2 (two) passes for Guests paddock

\*Permanent passes will be issued only to people in possession of the MEMBER F.M.I. 2024 card

b) One (Nr.1) car pass for authorized parking and One (Nr.1) technical pass both valid for the whole season and not transferable to third parties.
- 6) Paddock space for technical vehicle and workshop tent. **it will not be allowed to carry out commercial or promotional activities without authorization from the Italian Motorcycling Federation.**  
Cars can only be parked in the areas indicated by the Paddock Management Service.

The rider's envelope containing all the documents about to the race (including passes) must be collected by the rider or a parent.
